Quorum - 36 out of 41 attending Simple majority is 37 and 2/3s is 48.

Jean called the meeting to order at 8:12am and welcomed everyone to the NABO convention hosted by the Kern County Basque Club. Club president, Louis Iturriria, provided a rundown of the weekend's activities. Thanks to Francois and Christian for hosting the meeting at the Woolgrowers. The NABO Bizi Emankorra awards will be presented tonight at UC Bakersfield, and on Saturday there will be Mus, pilota, txerriki etc. and dance performances including groups from other clubs.

Maria Toretta - has some swag bags for everyone that include items that are representative of Kern County.

Jean thanks the Kern County Basque Club - Jean then introduces special friends from the Basque Country – Director of the Basque Community Abroad, Gorka Alvarez, and Benan Oregi, Unai Telleria and Nerea Arrieta from the Delegation of Euskadi to the US, and Arantxa Anitua and Asier Iriberri from FEVA, President and Vice President respectively. Arantxa has also served as the assesore for South America. Asier is the recently elected president of FEVA but has known Jean for about 32 years.

Minutes - Mayi moves and Philippe seconds to approve the minutes - all in favor - passes unanimously.

Treasurer's report - please refer to report in packet. Since the last meeting we did receive the balance of our 2023 Basque Government grant. Pilota activity is really ramping up thanks to Tony's enthusiasm, and we will now pay for players to go to Saint Pierre et Miquelon. We also paid for one trip to Grand Junction last weekend, when Plaza Urrutia was dedicated as a historical site. Mayi needs the delegates' help to get dues on time and in the right amount. Also, many claim that they do not know Mayi's address. We will be paying for airfare and insurance for two Ateak Ireki participants only after they pay \$500 towards the program. They won't receive reimbursement until they return. There was also one request from Aita Tillous fund for one Udaleku participant.

Finance committee report –The committee adopted a new policy on how to liquidate gifts of stock. We had received 81 shares of Apple Stock to split between three programs and during the time we waited, it decreased in value. They have now adopted the policy to immediately liquidate such gifts. Donors can share where to put money but not how to liquidate it.

Mayi is also working on a new report that reflects budget vs actuals. Bob moves to approve the treasurer's report and JP Etchechury seconds passes unanimously.

Basque Government- Gorka thanks us for all of the work we are doing. It is apparent to them that we are strong, and they see all the work we are doing well. He presents everyone who is with him - Unai, Nerea, Benan - also very important that the FEVA reps are here too since NABO and FEVA are the two largest federations in the world. Together we are stronger.

Gorka shares a PPT. The most important thing that happened over there since our last meeting was the elections. PNV won but tied in seats with EH Bildu and so now they are negotiating how to

build the government. The new lehendakari will be named by June 22 and so Gorka is not sure if he will continue in his current position. A very small number of votes came from the Diaspora. This would be a good opportunity to collaborate with the country but of course it is a volunteer act. If it goes as thought - Imanol Pradales will be the Lehendakari. He's from Santurtzi and is a professor at Deusto.

2023 Basque Government Grants - They. received 50 applications from 62 countries. Argentina received the most grants, and then us.

In 2024, the grant budget was increased to 980,000 Euros in two categories. There were seventy-one requests, eight of which were from the US. The first payment will come after the evaluation of the applications expected to pay the first 25% in July or early August. March 21, 2025, is last day to Justify the 2024 grants.

Gaztemundu - will take place September 15-29 and this year's theme is Dantza. This is open to individuals between the ages of 18-35. Gorka encourages US youth to participate in this program since it is a great opportunity to get to know the Basque Country

Basque Diaspora Archive - growing all the time.

Diaspora Eguna - over 100 activities took place around the world. It is important to show the world how we are doing. Video showing what happened in Gernika.

In 2024 Diaspora Eguna will be in Oñate - 2023 featured Australia and this year will celebrate the anniversary of the Oñate exchange program. We are all invited to come to Oñate this year on September 8th. There will be an exhibit on the exchange program as well as the presentation of the book written about it by Iñaki Galdos. Please let them know about any activity that is planned in our clubs.

The World Congress – was a very good experience, especially since we learned a lot about each other. We also created a 4-year plan.

Gorka turns the floor to Benan to talk about the new project next year. They are working with Jaialdi and creating an exhibit on Ellis Island. They are working on a new exhibit that they wanted to have ready for 2025 for Jaialdi but can't carry it out now because of construction on Ellis Island and the work won't be done in time. They are now redistributing their space and so the

temporary exhibit hall won't be ready until 2026. They are interested, for sure, but won't be able to do it until 2026. They have already met with the team like ten times and are working on a big project, but New Yorkers say 2026 will be good too because that will coincide with sports events in NY then. It is also good because the temporary exhibit room will now be on the 1st floor instead of the 3rd. It is estimated that four million visitors will go through there. The Basque Government set the condition that the exhibit is held during the summertime so viewed by the most people possible. They would like dancers every day to rotate to attract visitors. This will be during the summer of 2026, but exact dates aren't ready yet.

Unai -second visit to Bakersfield was here to open a chair with Etxepare.

Edurne – expresses concern about voting process. Ballots were not included and the consulates were not acting quickly. She appreciated Benan's help.

Gorka - you can download the ballot and send it that way.

Edurne - instructions would be helpful.

Gorka - will try to do something to streamline the process.

Asier Iriberri and Arantxa Anitua -

Asier presents FEVA – FEVA is currently comprised of 98 clubs. He shares a PPT that features their strongest programs

Argentinian Euskaraz - supported by Aurten Bai and HABE and now by Etxepare. They have 96 teachers and 1310 students. They are very proud of that program. He shares photos of teacher training.

They carry out many workshops and cultural exchanges as part of their educational programs. Started creating virtual talks and workshops during the pandemic which was very positive because it allows many to participate. Not only for people in Argentina, but also in Chile and Uruguay.

FEVA board meets monthly and once annually at Semana Vasca - many holidays celebrated from the Basque Country as well as Argentine holidays.

Semana Vasca, Buenos Aires Celebrates, Txiki meetings etc.

Semana Vasca is held annually, usually in November and includes participants from all over the world, as well as various activities.

Arantxa also says a few words - They are very happy to be here to share their work and love for the Baque culture. We are all invited to Semana Vasca in November in Bahia Blanca and it would be great if there were a group of US Basques there as well. They will also have a group from the Basque Government, as well as Korrontzi on its 20th tour. Mila esker!

Asier spoke and then Benan translated that he is very excited to be back. He came 30 years ago, 1994, and was hosted by the Etchemendy family and he tells us about this first experience here. He's very grateful for this invitation. The experience was, for the whole group, a once in a lifetime one. He also sends regards from others that were part of that group.

Jean – Thanks Arantxa and Asier and points out that they have similar programs. They are a lot like us, they are larger and have older institutions but have similar goals, Mus, youth programs etc. We will continue to talk about Euskara exchange programs etc. Maybe pilota exchanges and maybe dancers again. Thank you for coming.

Committee Reports - Please refer to the committee reports

WWII Committee – Mayi reports that she will demonstrate how the searchable database works. They have also put together a packet for each club so that you can have a better idea of what is going on. Philippe pulls up the database. Each of these individuals' research and stories have been completed. Since it is Memorial Day – She asks for a moment of silence to honor everyone who has served.

Slide show on committee members - Mark Etcheverry from the Fresno Basque Club is a new committee member. We have updated the website to include Pedro's presentation in San Francsico is now available there. We have collected about \$12K and maybe most importantly have

composed our mission statement. Mayi reads the mission statement "Our mission is to honor the valor, sacrifice, and enduring legacy of Basque WWII veterans who served with the United States Armed Forces, including the Merchant Marine, recognizing their profound contributions to freedom and democracy. Through commemoration, education, and advocacy, we pledge to ensure their stories are remembered, their sacrifices acknowledged, and their courage celebrated for generations to come." Mayi thanks Chris Bengoecha for putting that together. Club packages will be passed out, as well as emailed. We have begun placing ads in various booklets and hope to have the display at Jaialdi as well as a page in the NABO calendar. Future steps.

Mayi then demonstrates how the database works - the link will be sent to everyone as well. She demonstrates a positive and a negative search.

Jean - concerns about names from last meeting. You'll need to know what official names are. You can start a search and if it's not found, you email Pedro. Thank you for your hard work.

Education Report – Reported by John Ysursa - The Oñate program is in your packet – At the last meeting we agreed to rotate this chair. Boise State University is hosting it because of the Oñati anniversary. Diaspora Eguna in Oñati they hope to livestream the event as well. John Talks about Jaialdi schedule of events. Symposium etc. more information will be made available via Astero etc.

Jean - Arik Loinaz will also talk about the Soka Exhibit - trying to sell it and share it. Jean will approach clubs directly.

Arik - If you are interested in this great exhibit, please don't hesitate to reach out to him or to Valerie and he can share more details about it.

Ana Maria Echeverria - what is the exhibit?

It is on Soka Dantza features Basque dance - featured in 2022 with Etxepare it is in English Basque and French. An interactive exhibit.

Valerie - one thing that is holding clubs back is that no one club wants to be responsible for it. Maybe NABO could purchase the exhibit for 2026, at Ellis Island and shares it among clubs afterwards.

Jean - I'll do more research and we can talk more in Grand Junction.

Euskara Report - Ziortza everything is going well, and so she is very happy about that. Had to cancel the Topaketa but will try again in the fall. The relationship with Etxepare is great and all parties involved are very happy.

Edurne - refer to report in packet - majority of classes are beginning classes and highlights projects done by classes. Kids book, Agate Eguna etc. This year was a Korrika year, celebrated in Salt Lake City, Montreal, New York, Reno and San Francisco with txikis. Shows video of her group in San Francsico at txiki dance practice

Summer classes have begun with 30 students total.

Summer activities - Etengabeko Irakurketa - Bilbao-New York-Bilbao - Kirmen Uribe Some of our students are participating in it - shows a video of that reading. Will read two passages from that book.

Benan - This year's writer is Kirmen Uribe and Nerea is his wife.

Fall 2024 tell membership this is the only opportunity to start at complete beginners in the fall. \$125 for 12 weeks of class.

She is looking for a new fall date to reschedule the Topaketa. They were expecting participation from Quebec, and many online etc. and are hoping to redo it in the fall. Very important to keep teachers motivated.

Ingura Euskera.eus - free program for individual learning. Big step up from Aiza.

Patti Aramburu- Edurne is our most amazing cheerleader! Great asset for Seattle club and for Euskara.

Facilitator report - Since February, Kate has justified the 2023 Basque Government grant, and now we have received that payment in full. We had received \$7,219.00 or the first 25% of the grant prior to the San Francisco meeting, and more recently received the balance due or \$22,137.10, for a total of \$29,356.10. This year Kate had several meetings with Jean and Mayi and so we are hoping to be more successful this year. She also wrote and submitted NABO's 2024 Basque Government grant.

Lisa continues to investigate the best way forward for our NABO emails and website, but please ask everyone to make sure your information is correct on the website.

Break - till 10:25am

Mus Report – Pierre reports - all tournaments have now concluded. Thirty clubs hosted tournaments and 1,060 players participated. Mus is going well and there are many cash tournaments in conjunction with festivals. NABO Finals will be in Gardnerville on June 15th. There will be 41 teams competing there, and the winners will go to Cusco, Peru in October, where nine countries are expected to participate.

Created Mus regions about five years ago and it seems to be working well, individual chairs are doing a great job. They are also in charge of teaching the juniors.

Saint Pierre et Miquelon - four players - 2 women and 2 men pala players - first time participating in SPM, and he has been working on this for at least 2 years. SPM stepped up, they told us, "You get here and we'll take care of everything else." This could be the beginning of awesome things!

Jean - they have a new president and board that want to be more involved and asked about a dance teacher and Quebec helped them out with that too.

Tony - top players at San Francisco Besta and at Chino Second event in Grand Junction - picnic and NABO meeting September 21st.

Arantxa Anitua - we are developing adapted pilota for handicapped persons.

Tony - we haven't done anything with this to date, maybe we should consider how to do it.

Arantxa - they are just starting to develop in Rosario Basque clubs, and it is enjoying great success. If you'd like to collaborate maybe we can work together on that.

Mayi - we approved a \$1,000 donation to the World Federation of Pilota - Personal thanks from Mayi for bringing players to Grand Junction event. Without your dedication we wouldn't be able to do what we did

Jean - thanks Tony for bringing it back. There will be a pilota camp and information will be provided to everyone soon.

Txerriki and Gateau Basque contests - Txerriki on Saturday and Gateau on Sunday - 2pm outside BBQ start at 3pm. If you want to be a judge, see Valerie. Sunday after mass - can't be a professional baker is the only rule - Dominique Etchechury won last year, and so will judge this year. Drop off cakes after mass.

Udaleku - June 16-28, 2024, in San Francisco - Late applications this year due to difficulty in finding enough housing. Ninety-five kids will be housed with local families. Iparralde is the theme, and the Larraldes are the instructors from Donibane. There will also be a pilotari from Uztaritze and two from Boise camp. Encouraging everyone to bring instruments to put together a Banda. There won't be a specific Euskera class, but it will be incorporated in all activities. Trying to make it more practical.

There have been a couple of changes in the application. Valerie created a NABO DocuSign so made it easier for parents. Denis - 2026 Chino and 2027 Salt Lake City is interested. Nevada TBD Bob will ask the board will be confirmed in the fall.

Bakersfield and Boise held first post-COVID camps but in San Francisco we are moving back to two weeks.

Music Report - refer to report in the packet. A song from Esti Markez is included in the latest playlist. Foku Musica is on the website and the Spotify links are also there.

Dues Discussion -

Jean received a lot of feedback on the subject and so he feels it warrants more discussion. Please raise your hand so we aren't talking over each other - Jean reads his email message.

Now base would be \$342/club and \$3 per member or should be \$143/\$1.43 per member.

Proposal - tiered dues system 1-49 members - \$150 and retain all rights and access - 50 + \$100 base and \$3 per member - would hopefully offset some of the inflation. Also reinstate .25 the Aita Tillous portion from dues.

Valerie – took a deep dive into Udaleku – She proposed \$500 and 10% sibling discount expecting this amount to cover camp. The true cost of camp, food alone however, 110 people at \$50 day for 14 days that is \$77,000 in food cost alone - instructor stipend is \$15,000, airline tickets for instructors not counting World Pilota council travel and materials - \$6,000. These categories total \$100,000 not including supplies and excursions and if that was divided by 95 kids, tuition would be over \$1,000 per child. That is why she pushes to increase tuition by inflation annually. In terms of what the expense are, there are a lot of expenses behind the scenes that are not being accounted for.

Marianna Echeverria - wants to share what Chino's board discusses. Agree on an increase and agree that it should be regularly increased, maybe every other year. All committees should have a budget and follow that budget. All programs should be thinking out of the box, not just expecting NABO to cover expenses.

Becky - how many are over and under 50?

Jean 12-13 over 50

Becky – feels pass through is important and feels like smaller clubs would be penalized and if we increase dues, she feels like everyone should have the same increase.

Jean - maybe we can come up with a different formula. Most smaller clubs are our institutions Cenarrusa, CBS etc.

Jean Pierre Etchechury - clubs should create an event to raise money and dues could be raised easily. Events that expose non-Basques to our culture and bring our clubs together.

Patti - have you ever asked for frequent flier mile donations?

Valerie - we make a concerted effort for donations for Udaleku. We got donations, but then we were dinged for not having enough expense for the Basque Government grant. We will continue to run the program with donations, and that is what we have to be focusing on. This is why we invested some of our savings to grow funds to support programs in the future.

Jean - may be a good idea for officer travel.

Teresa Iturriria - we have 700 members - Kern County Basque Club - tried to come up with different ways. Maybe larger clubs would have more delegates if paying more?

Jean that was discussed, but that was not allowed and went on the house model to allow two votes per club so that it is fairer.

Valerie - that was discussed many times, but that is more of a proxy discussion.

Teresa Cox - We need to consider that we have so many programs that are like Udaleku that are significantly funded by the clubs. They are free because someone else is paying for it. Kantari, NABO Mus etc. are being funded by clubs. I'm not even aware all the time of what is available to individual members and clubs. Dues are very minimal. We have to justify to every person when increases are made.

Mayi - we have quite a few clubs whose sole purpose is Mus. They only have a Mus tournament, and they are already paying \$15 per player and if we increase their dues, what is that going to do to them since they exist only for Mus?

Jean - other comments

Gloria Lejardi - She is opposed to increasing dues, but we are not addressing reducing costs.

Valerie - Udaleku tries hard to stay on budget.

Jean - Gloria feels that it doesn't make sense to go into the red to qualify for grant monies.

Valerie - many costs that are absorbed by clubs. Luckily clubs that host those programs are able to make those costs.

Mayi - we do have to take a look at expenses, and we know that expenses are rising and I am sensitive that raising dues could be detrimental to some clubs. She insisted on budgets in Boise and the next part of that is holding chairs to their budgets. Pilota is a great example, so far, we only have \$800 for pilota but we are spending more than that. We need to get creative in order to fund Pilota. She is aware of looking at both sides of the equation.

Gloria - thanks Mayi

Bob - how much money are we looking for? How much do we have to raise dues?

Jean - We just started at raising \$3 per member as a starting point with a \$100 base. Feels that it warranted more discussion.

Valerie - Mayi, if we were to increase by \$2

Mayi - that makes an additional \$12,000 income.

Marianna - 6,000 members creates \$12,000 chairs really need to rethink what they are doing. I think our biggest hit is our Mus when we host International Mus, because we tour people everywhere. We have also lost countries in international Mus because they can't afford to host.

Jean - we are hoping to save Mus dues so that we have enough to host it.

Kate – reminds everyone that the Basque Government grant is a fixed amount.

Gloria T – she suggests presenting budget one or two in advance. Have we ever presented what we budget, and know what NABO's part is then? Have we ever gone that way? Forget about the Basque Government grant, think about other grant opportunities.

Mayi - we have not considered that approach, it's embarrassing but we are in the infant stage of insisting on budgets and managing budgets even after 50 years.

Gloria T. - if we are in the red, we need to use that new approach.

Mayi - Udaleku is not in the red, but it's numbers help in determining how much grant money we get. Our biggest deficit is our G&A costs - 3 salaries and officer travel and I'm volunteering my time. I'm the most expense person on the board and she is conscious of that.

Most programs are still in the black and in September we'll have a better idea with most costs are in.

Gloria T - is this raising dues in order to pay for the salary and board travel - legal fees.

Mayi - yes under G&A in financials

Gina E. - We need to look at fees in general. We don't need to be so specific about how we are going to spend it. It is generally to build the funds, that is why we should raise the dues for whatever we need it to be. Ten years ago, Pilota wasn't on anyone's radar and now it is.

Jean - our G&A is way above our income. Using grants etc. to make up the difference is not keeping up with inflation.

Teresa Cox - How much would the \$12k close the gap?

Jean - we have other ways of making money and that would help, but we would still have a gap.

Teresa Cox - we are getting into the weeds and not concentrating on specifics.

Jean - salaries - if we need to hire folks to write grants etc. and to run the website it would be more expensive.

Mayi - she puts in at least 20 hours a week and it would be a lot of money to pay a bookkeeper. We small clubs we could apply for a grant, but we would never qualify for a Basque Government grant and so we need to turn to NABO to function. NABO paying for pilota etc. We need help.

Benan - addresses the grant system and that it goes through a vast line of scoring systems. It works on various criteria, nearly 20 criteria lines they have to score so that small clubs can get grants as well. After 40 years they have worked on this program, and they have not had an increase in over 20 years and so they are working on that too. Only a small number of clubs write applications from the US. Most of the clubs that apply are small. The limit for clubs is 30,000 Euros and the federation's limit is 50,000 Euros. A small club could get 10-12,000 Euros. Can't say in advance because it is a contest among 71 clubs from 10 countries and we can't foresee what the multiple realities are. Don't be afraid to apply.

Becky - Dues seems like more members are attracted by Mus, would \$2 keep you away from different tournaments? The answer is no.

It is a pass through, and the feeling is that this would not dissuade folks

Jean - thank you everyone, please send him your thoughts.

Valerie - if we were to raise it by \$5 what would that be?

Mayi - \$5 per member would be too difficult for smaller clubs. Harder for them to take advantage of NABO programs in remote areas.
